B. Reports from the Director of Education and Student Trustee(s):

1. <u>Report from the Director of Education.</u>

Mr. Michael Nasello, Director of Education, shared his report with the Board and highlighted that:

- The Board added its voice to the collective response with many other Peterborough organizations and individuals in expressing concern over the planned white supremacist rally and in lending our vocal support to the quality of community life here in Peterborough that is welcoming, supportive and respectful of all people.
- The Rosary Prayer Program and Diocesan Sacramental Preparation Program are well underway.
- Development of CBIPSAW, 17-18 benchmarks for the first stages of our new Strategic Plan Implementation, and follow up plan for our EQAO.
- EQAO Data has been released.
- We are busy supporting the United Way and the Special Olympics is coming in May 2018.
- When Faith Meets Pedagogy Conference takes place later this week and the Board is presenting on Deep Inquiry Learning.
- The CEFO Fr. Fogarty Student Award recipients will be recognized this weekend.
- Strong secondary student delegation attended WE Day from various schools.

- Catholic Leadership Development Series is on November 8, 2017 with Jennifer Kolari as the keynote speaker and she will also present to the Catholic Parent Engagement Committee the same evening. All parents are encouraged to attend the evening.
- Chiefs of the First Nations meetings are in progress and more are planned. The Bishop has been introduced at these meetings.
- On October 30, 2017 he joined Ms. Jennifer Leclerc, Director KPR and Chief Murray Rodd, on a public panel discussion around Bullying sponsored by the Ontario College of Teachers. Trustees are invited to attend the event taking place at the Holiday Inn, Peterborough at 9:00 a.m.
- On November 2, 2017 there will be a Mass for the Deceased Members of the PVNC community at the Cathedral at 4:30 p.m.
- On November 3, 2017 the annual retirement celebration will take place.
- Renewing the Promise roundtable event takes place on November 14, 2017. Building on past dialogue.

2. <u>Report from the Student Trustee(s).</u>

Ms. Calahndra Brake, Student Trustee, shared her report with the Board and highlighted that:

- All secondary schools participated in Orange Shirt Day "Every Child Matters" as an opportunity to further the discussion on all aspects of residential schools.
- Student Councils and Link Crews across the Board are having planning days and retreats. Link Crew is a secondary school orientation and transition program lead by trained senior students mentoring junior students.
- Dances are taking place at secondary schools.
- Holy Cross students lead an initiative where students wore a red ribbon to honour the lives of missing and murdered Indigenous women in Canada.
- Food drives and various fundraisers are taking place such as "Socktober" a sock drive inspired by "Me to We".
- Schools are working on their musical productions with a few being:
 - Grease Holy Cross Catholic Secondary School
 - Beauty and the Beast St. Peter Catholic Secondary School
 - James and the Giant Peach Holy Trinity Catholic Secondary School
- Progress reports have been sent out to students.

C. Presentations:

1. Ontario Association of Parents in Catholic Education (OAPCE).

Mr. Dave Bernier, Chairperson, welcomed Ms. Lisa Cuypers, OAPCE Administrative Assistant, to the Board Meeting and thanked her for taking the time to meet and answer questions from the Trustees.

Ms. Lisa Cuypers, attended the Board meeting as the representative of the Ontario Association of Parents in Catholic Education in response to a letter sent by the Board to OAPCE on September 25, 2017.

Ms. Cuypers handed out the OAPCE Year-End Report 2016-2017 to Trustees.

Mr. Dave Bernier, Chairperson, inquired about the focus of the organization and its provincial perspective in relationship to all Boards. Ms. Cuypers shared that they are a Provincial Organization and their goal is communication across the province. The Board of Directors has representation from several Boards as listed on the handout. Within the communication process, some Boards have separate parent email groups connected with Board email groups making easier communication flow while with other Boards emails are personal and may not be as accessible due to freedom of information concerns.

Ms. Cuypers informed Trustees that the Vice president of OAPCE has attended the Institute for Catholic Education (ICE) meetings. All members of the OAPCE, other than Ms. Cuypers, are volunteers and the home office, where she works is now in Petawawa.

The Board inquired around the removal of the Spiritual Director from the OAPCE table and Ms. Cuypers shared with Trustees that Bishop Joseph Dabrowski from the Diocese of London is the new OAPCE Liaison Bishop appointed by the Assembly of Catholic Bishops of Ontario who is invited to the BOD meetings as the Bishop Liaison and as the Spiritual Advisor.

Ms. Cuypers indicated the OAPCE AGM is coming up and that the revised OAPCE ByLaws will be shared at the meeting.

The Board inquired on the OAPCE communication process. Ms. Cuypers responded that when documentation is received it is shared with the executive. The OAPCE Board meets every three months. Ms. Cuypers advised Trustees that the executive will be at the upcoming ICE Symposium and can answer any further questions at that time.

Ms. Cuypers shared that OAPCE will be celebrating its 80th Anniversary in 2019.

Mr. Dave Bernier, Chairperson, thanked Ms. Cuypers for her time and for attending as a representative of OAPCE and answering questions.

2. Communications Awards.

Mr. Michael Nasello, Director of Education, shared with Trustees that Mr. Galen Eagle, Communications Manager, was recognized by the Canadian Association of Communicators in Education for two 2017 BRAVO Awards. Mr. Eagle received the 2017 BRAVO Award of Distinction for "A Syrian Journey" and "PVNC Vimy 100" communication pieces.

The Board congratulated Mr. Eagle on the awards and thanked him for his dedication and work.

3. <u>Proposed St. Mary Catholic Secondary School, Cobourg, Student Excursion to Italy and</u> <u>Greece from March 7, 2019 to March 16, 2019.</u>

Mr. Rob Majdell, Principal, and Mr. Curtis Chornie, Teacher, shared detailed excursion packages with Trustees and answered questions. Trustees also inquired around optional excursions and were informed that any optional excursion will include the entire group. Mr. Chornie will also be offering this excursion to other schools.

that the proposed St. Mary Catholic Secondary School, Cobourg, student excursion to Italy and Greece from March 7, 2019 to March 16, 2019 be approved in principle and that the trip will include mandatory insurance for all travelers. Such insurance must cover school board or

principal rulings for cancellation of the trip.

4. <u>Proposed St. Mary Catholic Secondary School, Cobourg, Student Excursion to San</u> <u>Francisco, United States, from April 6, 2018 to April 10, 2018 – Invitational Music Festival.</u>

Mr. Rob Majdell, Principal, and Ms. Tanya Earle, Teacher, shared detailed excursion packages with Trustees and answered questions.

Ms. Earle informed Trustees that this music competition is by invite only from the Heritage Music Group. If this excursion is approved fundraising opportunities will be put in place. Trustees inquired around cancellation insurance and Ms. Earle indicated this is still outstanding but she is following up on this with the Heritage Music Group.

Mr. Mark Joly, Principal, Mr. Bryan Landry and Mr. Rob Morrison, Teachers, shared detailed excursion packages with Trustees and answered questions.

Mr. Landry advised Trustees that he has connected with Mr. Hulsman, Teacher, at St. Thomas Aquinas Catholic Secondary School and shared an invitation for students to join St. Stephen Catholic Secondary School on this excursion pending Board approval of the excursion.

Mr. Mark Joly, Principal and Ms. Michelle Driscoll, Teacher, shared detailed excursion packages with Trustees and answered questions. Mr. Joly indicated he will connect with Mr. Winn, Principal at St. Thomas Aquinas Catholic Secondary School, to offer this excursion to their students pending Board approval of the excursion.

that the proposed St. Stephen Catholic Secondary School, Bowmanville, student excursion to France from March 7, 2019 to March 14, 2019 be approved in principle and that the trip will

7. <u>Proposed Holy Cross Catholic Secondary School, Peterborough, Student Excursion to</u> <u>Chicago, Illinois, United States from April 26, 2018 to April 29, 2018.</u>

Mr. James Brake and Ms. Janina Kraus, shared detailed excursion packages with Trustees and answered questions.

MOTION: Moved by Mr. Dan Demers, seconded by Ms. Christine Dunn,

that the proposed Holy Cross Catholic Secondary School, Peterborough, student excursion to Chicago, Illinois, United States from April 26, 2018 to April 29, 2018 be approved in principle and that the trip will include mandatory insurance for all travelers. Such insurance must cover school board or principal rulings for cancellation of the trip.

8. 2017 Summer Learning Program Update.

Mr. Tim Moloney, Superintendent of Learning/Student Success, gave a brief summary to Trustees on the Summer Programs that were offered in 2017.

a) Summer Learning Program 2017.

Mr. Wayne Clark, Principal-Summer Learning Program, shared with Trustees that "Camp Aim" was offered to students in grades 1-6. Classes were offered at St. Anthony Catholic Elementary School in Port Hope, Holy Family Catholic Elementary School in Courtice, St. Patrick Catholic Elementary in Peterborough and St. Dominic Catholic Elementary School in Lindsay.

This program offered learning through communication, and problem solving in math and robotics coding. Parents joined students at the beginning and end of each day, with several activities and excursions being offered to explore connections to numeracy, literacy, science and the arts.

This program supported one teacher and one tutor per class. One robotics instructor was supported per two sites.

b) Summer School 2017.

Ms. Bridget McCann-Girard, Principal - Summer School 2017 informed Trustees that Summer School 2017 was offered at St. Stephen Catholic Secondary School in Bowmanville and Holy Cross Catholic Secondary School in Peterborough. Ms. McCann-Girard reviewed that, with the implementation of student success initiatives in our schools, there is a reduced need for remediation and now we are seeing an increase in reach ahead opportunities for students offered through the Catholic Elearning Consortium. Summer Course offerings included math remediation, face to face, and online reach-ahead opportunities, elearning courses and community connected experiential learning. Over 500 credits were completed in Summer School 2017.

Mrs. Margaret Murray, Student Achievement Consultant, informed Trustees that the Grade 7 and 8 Literacy and Numeracy is a not-for-credit program that was offered at both Summer School locations. Mrs. Murray indicated that this program has moved from remediation to growth mindset in developing student skills. Career exploration

opportunities were offered this year along with physical activities and leadership development.

c) Focus on Youth 2017 Summer School.

Mr. Alex Duketow, Student Achievement Consultant, informed Trustees that Focus on Youth was an opportunity offered in conjunction with Trent Aboriginal Cultural Knowledge and Science (TRACKS). Ten elementary students participated in five day camp experience with two secondary students being hired as camp leaders. The secondary students also earned coop credits.

Trustees thanked the staff for the presentations and for offering such a great variety of experiences to meet student needs.

9. EQAO Presentation.

Mrs. Dawn Michie, Superintendent of Learning/Program K-12 and Ms. Sandra Connolly Student Achievement Consultant, shared a presentation with Trustees and answered questions.

EQAO data was released publically on Wednesday September 20, 2017 and looked at a five year data trend. Mrs. Michie reviewed timelines of the assessments and shared a grade six math question with Trustees as a sample.

EQAO data was reviewed with Trustees through charts showing the status of the Board compared to the Province in a year over year analysis from 2012-2013 to 2016-2017.

Areas of growth and needs were reviewed and next steps shared. Junior Math needs are being supported by the Board through the renewed math strategy, itinerant math teachers, math mentors at each school, P.A. Days with a numeracy focus and supports for special education teachers regarding learning disabilities in math. The Ministry of Education supports include integrated literacy program, Principal supports with MOE coaching, Student Achievement Officers supporting increased intensive schools, collaborative inquiries and professional learning.

The Board thanked the group for the thorough presentation.

10. CBIPSAW Catholic Board Improvement Plan for Student Achievement and Well-Being.
